ACTION ITEMS:

1. Approval of collective bargaining agreement by and between the City of Ottumwa, Iowa and the Teamsters Local 238, representing Public Works, Parks, Airport and Cemetery employees, commencing July 1, 2012 and continuing through June 30, 2016, and authorizing the Mayor to sign the agreement.

RECOMMENDATION: Approve collective bargaining agreement by the parties effective July 1, 2012 through June 30, 2016, and authorize the Mayor to sign said agreement.

2. Approval of collective bargaining agreement by and between the City of Ottumwa, Iowa and the Teamsters Local 238, representing the municipal employees, commencing July 1, 2012 and continuing through June 30, 2016, and authorizing the Mayor to sign the agreement.

RECOMMENDATION: Approve collective bargaining agreement by the parties effective July 1, 2012 through June 30, 2016, and authorize the Mayor to sign said agreement.
